Virtual Public Hearing Set for Solar Facility Proposed for Cecil County

(BALTIMORE, MD) – Local residents and other interested members of the public are invited to comment on a proposal by Bouchelle Road Solar 1, LLC to construct a 5.0 MW solar generating facility in Cecil County. The virtual hearing will take place on **Tuesday, December 16, 2025 at 6:00 p.m.** before Public Utility Law Judge Christine L. Burke.

In June 2025, the developer applied to the Maryland Public Service Commission for what is known as a Certificate of Public Convenience and Necessity (CPCN), which grants an applicant the authority to construct an energy generating station in Maryland. According to the application, the developer proposes to build the project on approximately 37 acres of a 111-acre property at 600 Bouchelle Road in Elkton. The project is proposed as a community solar system to serve local subscribers within Delmarva Power's service territory, including low- and moderate-income households in the Elkton area.

In addition to taking comments from the public, the hearing will include a presentation by the applicant, brief statements by the parties, including the Power Plant Research Program of the Maryland Department of Natural Resources, and the Commission's Technical Staff, as to their respective roles in the case.

- Click 'Schedule Event'
