## Public Comment Hearings Set for Columbia Gas Rate Case

(BALTIMORE, MD) – The Maryland Public Service Commission has scheduled two public comment hearings for the rate increase request filed by Columbia Gas of Maryland. Columbia Gas provides natural gas distribution services to 34,000 customers in the western Maryland counties of Allegany, Garrett and Washington.

Columbia Gas, a subsidiary of NiSource, Inc., has requested an \$8.8 million rate increase which it says is necessary to recover the costs of the company's increased investment in the replacement of leak-prone pipelines, and increased operation and maintenance expenses. The proposed rates would result in an increase of approximately \$14.73 on the monthly bill of an average residential customer (or close to 14 percent).
