Maryland PSC to Hold Virtual Public Hearing For Proposed Solar Project in Dorchester County

(BALTIMORE, MD-May 21, 2020) – The Maryland Public Service Commission will hold a virtual public comment hearing **Wednesday, June 3, 2020 at 7 p.m.** on a request by New Market Solar, LLC to build a 50 MW solar generating facility in Dorchester County. The project is proposed for a 286-acre site on a parcel bounded by Thompsontown Road, Railroad Avenue and Richardson Road in East New Market. The hearing will be conducted by Public Utility Law Judge Kristin Case Lawrence.
