## **Maryland PSC to Hold Second Round of Public Hearings for BGE Transmission Line Project**

*Hearings scheduled for Anne Arundel County, Baltimore City and County*

(BALTIMORE, MD-December 2, 2019) – The Maryland Public Service Commission will hold an additional three public comment hearings on a request by Baltimore Gas and Electric Company to modify an existing 230 kV electric transmission line. The 'Key Crossing Reliability Initiative Transmission Line Project' would modify the existing transmission line that runs between the Riverside Substation in Baltimore County and the Brandon Shores Substation in Anne Arundel County. BGE proposes to replace approximately 2.25 miles of cable beneath the Patapsco River (between Hawkins Point and Sollers Point, parallel to the Francis Scott Key Bridge) with overhead wire and eight support structures. An initial set of public hearings was held in September 2019.

Members of the public who wish to comment on the proposal are welcome to attend one or all of the hearings before Public Utility Law Judge Kristin Case Lawrence. The hearings are scheduled as follows:
