Maryland PSC Schedules First Public Hearing for Kent County Solar Project

(BALTIMORE, MD-April 10, 2019) – The Maryland Public Service Commission will hold a public comment hearing on the application of Morgnec Road Solar, LLC to build a 45 MW solar generating facility in Kent County, Maryland. The hearing will be held on **Wednesday, April 24, 2019, at 7:00 p.m. on the campus of Washington College (in the Norman James Theater located in William Smith Hall), 300 Washington Avenue in Chestertown.** Members of the public who wish to comment on the proposal are welcome to attend the hearing before Public Utility Law Judge Kristin Case Lawrence. A second public comment hearing is planned for October 2019 at a date, time and location to be determined.

According to the application, the solar array will be constructed on two parcels totaling more than 250 acres near the town of Chestertown. The plans also include accompanying interconnection facilities necessary to connect the project to the Delmarva Power & Light Company's Chestertown Substation.

The application is available for public inspection or copying at the Kent County Department of Planning, Housing and Zoning, 400 High Street, Chestertown, Maryland 21620.
