## **Maryland Public Service Commission Sets Second Public Hearing for Brick Kiln Road Solar Project in Wicomico County**

(BALTIMORE, MD-November 30, 2017) – The Maryland Public Service Commission will hold a second public comment hearing on the application of Brick Kiln Road Solar, LLC to construct a 5.4 MW solar generating facility in Wicomico County, Maryland. The hearing will be held on **Wednesday, December 13, 2017, at 6:30pm at La Quinta Inn and Suites, 300 S. Salisbury Boulevard in Salisbury, Maryland.** This proceeding follows an initial public comment hearing held on September 26, 2017. Members of the public who wish to comment on the matter are welcome to attend the hearing before Public Utility Law Judge Ryan C. McLean.

According to the application, the solar facility and an accompanying interconnection distribution line will be constructed on approximately 36 acres of property located near the intersection of Brick Kiln Road and Owens Branch Road adjacent to the Lower Shore Enterprises in Salisbury, Maryland. Copies of the application are available for public inspection and copying at the Wicomico County Planning and Zoning Department, 125 N. Division Street #203, Salisbury, Maryland 21801.
