Public Hearing Scheduled in Kent County for Mills Branch Solar Project

(BALTIMORE, MD-June 8, 2016) – A public hearing for comment will be held on **Tuesday, June 21, 2016 at 6pm** in the matter of the application of Mills Branch Solar, LLC to construct a 60 MW solar photovoltaic generating facility in Kent County.
