**PUBLIC UTILITY LAW JUDGE'S
NOTICE OF PUBLIC COMMENT HEARING**

On September 26, 2025, Harford Calvary Solar 1, LLC filed an application (“Application”) for a Certificate of Public Convenience and Necessity (CPCN) for authority to construct a 2.5 megawatt alternating current fixed-tilt solar photovoltaic community solar energy generating facility in Harford County, Maryland (the “Project”).¹ The Project is anticipated to occupy approximately 11.69-acres of an approximately 53.86-acre property located along the northwest side of Maryland Route 543 (S Fountain Green Road/Creswell Road) and Maryland Route 136 (Calvary Road) as described by Tax Map 57 Parcel 2 in Harford County, Maryland (the “Property”).

An evening hearing for the purpose of receiving public comments in connection with the Application is hereby scheduled as follows:

The hearing will begin with a presentation of the proposed Project by the Applicant; followed by a presentation by the Department of Natural Resources (DNR), Power Plant Research Program (PPRP) of its recommendations with respect to the proposed Project; and followed by the Technical Staff of the Public Service Commission of Maryland (“Staff”) as to its recommendations regarding the proposed Project.

If any member of the public is unable to attend in-person but would like to participate virtually, they may sign up through the Public Service Commission of Maryland's ("the Commission's") website <https://psc.maryland.gov> by **Tuesday, September 8, 2026**. On the Commission's home page, scroll down until reaching the section titled "Comment on a Case." Under that section, click the link for "Learn More." On the next page, scroll down to the Calendly application. Scroll to the entry for "9816-Harford Calvary Solar 1 (CPCN)" and take the following steps: click the box for "9816-Harford Calvary Solar 1 (CPCN)"; click on September 10, 2026; select 6:30 p.m. and click on "Next"; and enter your name and email address and click "Schedule Event." You will receive a zoom link for the meeting once you have completed the sign-up process. Otherwise, barring technical difficulties, the hearing will be live-streamed and a recording will be available on the Public Utility Law Judge Division's YouTube Channel.²

Written comments on the proposed Project may be submitted electronically or by first-class mail through **September 11, 2026**. Commenters utilizing the Commission's e-file system are required to complete a one-time registration. The Applicant is hereby directed to:

- Once in each of the four successive weeks immediately before the public hearing date:

Publish notice of the hearing, including the caption, case number, location of the proposed Project, time, date, and location of the hearing, as a display advertisement in a newspaper of general circulation throughout Harford County, including in the notice how members of the public may participate or view the hearing, as well as the methods and date by which written comments may be submitted; and

Post on at least two routinely used social media platforms, such as Facebook or X (f/k/a Twitter), and use any other reasonable means of communications at its disposal to further notify Harford County residents/businesses of the date, time, and purpose (including the case caption, case number, location of the proposed Project, and link to the PULJ Division's YouTube Channel) of the hearing, and how members of the public may participate or view the hearing, as well as the methods and date by which written comments may be submitted.³

- Post continuously on the Applicant's website for the four weeks immediately preceding the public hearing date, notice of the hearing, including the caption, case number, location of the proposed Project, time, date, and location of the hearing, and how members of the public may participate or view the hearing, as well as the methods and date by which written comments may be submitted.
- Prominently post on the day of the hearing, an informational sign at or near each public entrance of the Holiday Inn Belcamp, which shall be at least 17 inches by 22 inches in size, and state the time, room number, and subject of the public hearing in a font size greater than 48 point and as large as the sign allows. The Applicant shall file an affidavit certifying that the necessary properly sized informational sign(s) were posted as directed, including a photograph of the informational sign(s) near or at the public entrances of the building, within two business days after the public hearing.
- File a certificate(s) of publication and a certificate of compliance with all other methods of providing notice set forth herein with the Commission on or before the date of the hearing.
